What is the Canadian Research and Development Tax Credit (SR&ED)?

SR&ED, or Scientific Research & Experimental Development (SR&ED) is a Federal program designed to encourage technological advancement.

It enables recapture of as much as 68% of money spent on eligible activities by Canadian companies by way of a tax credit (or cash refund).



How we do it

What costs are covered by the program?



A large portion of salaries of all employees and portion of the shareholder's salaries engaged in the projects, contractor fees as well as cost of all materials used or consumed in the course of the research work may be recoverable under this program.

What types of projects are considered eligible?

Many of the activities undertaken by Canadian companies considered "routine work" is actually eligible under the SR&ED program. SRED is all about technological advancement and the following are just some of the activities that may qualify:

- Developing a new product
- Improving an existing product
- Improving an existing manufacturing process
- Conducting in house R&D
- Developing software in house to overcome a technical challenge

What is the SR&ED claims process?

- We write up the technical report, collate financial data and present a draft report to you
- We file and defend and support the claim with CRA
